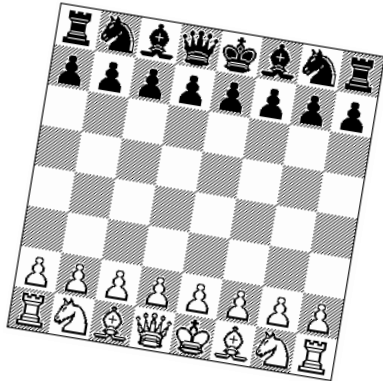




**Denver North High School
